DIRECTIONS FOR USE

PhycoTerra® ST is suitable for all crops at a use rate range of 1 to 6 fl. oz per hundredweight (CWT) applied on the seed as a treatment - simultaneously or in a tank mix with other treatments, such as fungicides, insecticides and biologicals. As a precaution, those using PhycoTerra® ST with other treatments in a blend must do a jar test first for mixing compatibility and a pH test to ensure no negative impact on living inoculants.

SHAKE OR AGITATE THOROUGHLY BEFORE USE

Settling of microalgae is normal and vigorous mixing is essential.

STORAGE RECOMMENDATIONS

For best results, it is recommended to keep this product in its original packaging until use and then used in its entirety after opening. For multiple use, the container should be sealed properly after each use and stored in a dry cool place. Avoid spillage as product may create a slip hazard.

PRECAUTIONS FOR USE
