PRODUCT INFORMATION

Rizoliq TOP HC with Osmo Protector Technology is a single component, naturally occurring, non-pathogenic bacterial product formulated to include Osmo Protector Technology for extended bacteria viability.

These are symbiotic nitrogen-fixing bacteria for use with soybeans designed to be applied through an approved application device at a retail location by persons who are trained in the proper methods of handling and applying inoculants to soybean seeds.

APPLICATION RATE

1.5 fl oz per 100 lb of seed (0.975 ml per kg of seed)

DIRECTIONS FOR USE

- · Use this product before expiration date stamped on the container.
- Ensure treater is properly cleaned and calibrated prior to use.
- Shake the bladder well before pouring contents into the application tank.
- Pour Rizoliq TOP HC with Osmo Protector Technology into application tank.
- Start application tank agitation.
- Apply at recommended rate.
- Once opened, use the entire contents of the bladder within 24 hours.

SEED TREATMENT COMPATIBILITY

- To maximize on-seed survivability of the rhizobia apply Rizoliq TOP HC with Osmo Protector Technology in a separate tank from all other seed treatment products. Either a simultaneous or sequential application method can be used when additional active chemical, polymer, colorant and nutritionals are also applied to the seed.
- · Additional water, polymers, dyes, beyond what is required to treat seeds is not recommended.
- · Do not use chlorinated water.
- Protect inoculant and treated seed from direct sunlight and high temperatures.
