APPLICATION TYPE	RATE	GENERAL RECOMMENDATIONS
Foliar Applied	0.25 to 1 quart per acre in standard tank mix.	Apply at typical foliar nutrient and crop protection timings.

DIRECTIONS FOR USE

Consult your crop adviser for specific crop applications. PhycoTerra® FX fully mixes in water and is suitable for use in liquid irrigation applications. Application can be made via foliar spray, pivot irrigation, or other methods which effectively apply PhycoTerra® FX to the leaf. Apply as a foliar application at 0.25-1 qt/acre (vol/vol) along with standard adjuvants, such as but not limited to spreader-stickers, foliar fertilizer, and/or crop protection materials in enough total volume to cover desired foliage. PhycoTerra® FX needs to be shaken or agitated to ensure full suspension of product prior to measuring and adding the product to the application mix. Supply tanks and spray tanks should have agitation.

STORAGE RECOMMENDATIONS

For best results, it is recommended to keep this product in its original packaging until use and then used in its entirety after opening. For multiple use, the container should be sealed properly after each use and stored in a dry cool place. Avoid spillage as product may create a slip hazard.

PRECAUTIONS FOR USE

FIRST AID
