### DIRECTIONS FOR USE

PhycoTerra® Organic fully mixes in water and is suitable for use in liquid soil applied and irrigation applications. Application can be in the seed furrow, T-banded, side-dressed along the seed furrow (2 x 2), or via flood, drip or pivot irrigation or other methods which effectively apply PhycoTerra® Organic to the soil. PhycoTerra® Organic needs to be mixed or agitated to ensure full suspension of product prior to measuring and adding the product to the application tank. Supply tanks and spray tanks should have agitation.
